## SECTION 2 – HAZARDS IDENTIFICATION

<b>Classification of Danger</b>	See section 14.
<b>Primary Route(s) of Exposure</b>	Eye, skin contact, ingestion.
<b>Health Hazard</b>	The batteries are not hazardous when used according to the instructions of manufacturer under normal conditions. In case of abuse, there's Hazard of rupture, fire, heat, leakage of internal components, which could cause casualty loss. Abuses including but not limited to the following cases: charged for long time, short circuited, put into fire, whacked with hard object, punctured with acute object, crushed, and broken.

## SECTION 4 – FIRST AID MEASURES

**Eye contact** Flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical aid.

**Skin contact** Remove contaminated clothes and rinse skin with plenty of water or shower for 15 minutes. Get medical aid.

**Inhalation** Remove from exposure and move to fresh air immediately. Use oxygen if available.

**Ingestion** Give at least 2 glasses of milk or water. Induce vomiting unless patient is unconscious. Call a physician.

## SECTION 5 – FIRE FIGHTING MEASURES

**Characteristics of Hazard** Dusts at sufficient concentrations can form explosive mixtures with air. Combustion generates toxic fumes.

**Hazardous Combustion Products** Carbon dioxide.

**Fire-extinguishing Methods** For small fires, use water spray, dry chemical, carbon dioxide or chemical foam.

**Attention in Fire-extinguishing** Wear self-contained breathing apparatus in pressure-demand, MSHA/NIOSH (approved or equivalent) and full protective gear.

## SECTION 6 – ACCIDENTAL RELEASE MEASURES

**Personal Precautions, protective equipment, and emergency procedures** In case of rupture. Attention! Corrosive material. Avoid contact with skin, eyes and clothing. Ensure adequate ventilation. Use personal protective equipment as required. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak. Refer to protective measures listed in Sections 7 and 8.

**Environmental Precautions** Prevent product from contaminating soil and from entering sewers or waterways.

**Methods and materials for Containment** Stop the leak if safe to do so. Contain the spilled liquid with dry sand or earth. Clean up spills immediately.

**Methods and materials for cleaning up** Absorb spilled material with an inert absorbent (dry sand or earth). Scoop contaminated absorbent into an acceptable waste container. Collect all contaminated absorbent and dispose of according to directions in Section 13. Scrub the area with detergent and water; collect all contaminated wash water for proper disposal.

## SECTION 7 – HANDLING AND STORAGE

**Handling** The battery may explode or cause burns, if disassembled, crushed or exposed to fire or high temperatures. Do not short or install with incorrect polarity.

**Storage** Store in a cool, dry, well-ventilated area away from incompatible substances. Store locked up. Keep out of the reach of children.

**Other Precautions** In case of rupture. Handle in accordance with good industrial hygiene and safety practice. Avoid contact with skin, eyes or clothing. Use personal protection equipment.

## SECTION 8 – EXPOSURE CONTROLS / PERSONAL PROTECTION

**Engineering Controls** Use adequate ventilation to keep airborne concentrations low. If used under conditions that generate particulates, the ACGIH TLV-TWA of 3mg/m<sup>3</sup> respirable fraction (10mg/m<sup>3</sup> total) should be observed.

**Personal Protective Equipment** **Eye and Face Protection** None required for consumer use. If there is a Hazard of contact: Tight sealing safety goggles. Face protection shield.

**Skin and Body Protection** None required for consumer use. If there is a Hazard of contact: Wear protective gloves and protective clothing.
